PLEASE READ THIS FORM CAREFULLY AND BE AWARE THAT IN SIGNING-UP AND PARTICIPATING IN CHEYENNE HOUSING AUTHORITY/LARAMIE COUNTY SENIOR SERVICES PROGRAMS INCLUDING BUT NOT LIMITED TO REGULAR MEETINGS, FIELD TRIPS, PARTIES, SPECIAL EVENTS, SPECIAL PROGRAMS, AND CLASSES, YOU WILL BE EXPRESSLY ASSUMING THE RISK AND LEGAL LIABILITY, AND WAIVING AND RELEASING ALL CLAIMS FOR INJURIES, DAMAGES OR LOSS WHICH YOU MIGHT SUSTAIN AS A RESULT OF PARTICIPATING IN ANY AND ALL ACTIVITIES CONNECTED WITH AND ASSOCIATED WITH THIS PROGRAM/ACTIVITY (INCLUDING TRANSPORTATION SERVICES/VEHICLE OPERATION, WHEN PROVIDED).

I recognize and acknowledge there may be certain risks of injury to participants in this program/activity/trip, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, I may sustain as a result of said participation. I further agree to waive and relinquish all claims I may have, or which may accrue to me, as a result of participating in this program/activity/trip against the Cheyenne Housing Authority/Laramie County Senior Services, its officials, agents, volunteers and employees. I will abide by a code of conduct whereby a civil respect is granted to other members and guests of the Senior Center, and Cheyenne Housing Authority/Senior Center staff. No rude behavior, verbal profanity, or physical threats will be tolerated.

Refund Policy:

- Refunds **will not** be granted if you cannot make a class due to illness, travel, or personal reasons.
- A refund **will** be given if adequate notice is given and your space can be filled.
- Refunds **will** be given if event is cancelled by Laramie County Senior Services.
- In special circumstances only, balances can be “rolled over” to the next session of the same class or activity.

Caregiver Policy:

It is the intent of the Senior Center to provide travel opportunities that are educational and stimulating for a wide variety of interests. Due to the time-intensive nature of supervising such an event, our staff cannot be responsible for providing personalized caregiving attention to individuals, i.e. assisting with ambulation, toileting, dining, cognitive impairments etc. Therefore the Senior Center reserves the right to deny a travel registration if it is determined that caregiving of this nature is required by a traveler and if a caregiver whether professional or family member is not provided by the traveler.

I do hereby fully release and forever discharge the Cheyenne Housing Authority/Laramie County Senior Services from any and all claims for injuries, damages, or loss that I may have or which may accrue to me and arising out of, connected with, or in any way associated with this program/activity/trip.

I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims.
